**Notification for 2nd counseling to fill up the vacant seats for admission to BPT/BOT/BPO courses at NILD Kolkata, SVNIRTAR-Cuttack, NIEPMD-Chennai and PDUNIPPD through CET-2022**

**Reporting Date:** 11<sup>th</sup> November 2022, **Reporting Time:** 9.00 A.M. to 11 A.M, **Venue:** National Institute for Locomotor Disabilities (Divyangjan), B.T. ROAD, BON-HOOGHLY, KOLKATA-700090

**Eligibility:** Admission will be made as per Common Merit Rank or as per category if seat reserved for that category.

a. All the candidates from Common Merit Rank 2165 to 2250 of the CET-2022 result.

b. Candidates who are already admitted at NILD-Kolkata, SVNIRTAR-Cuttack, NIEPMD- Chennai and PDUNIPPD-New Delhi through 1st counseling CET-2022 are eligible (if they are interested in change/transfer of institute/course) subject to availability choice of seat as per combined merit list. No further request for change of institute/course will be entertained.

c. Any other candidates who have attended 1st Counseling not got choice of seat but otherwise eligible within the Common Merit Rank -2164 of the CET-2022 result.

d. Candidates who appeared in the 1<sup>st</sup> counseling and refused admission are not eligible.

e. Candidates who did not appear in the 1<sup>st</sup> counseling are not eligible.
