Notification of e-counselling for CET-2023

Notification for e-counselling for Common Entrance Test (CET-2023) held on 9th July 2023 for admission to BPT/BOT/BPO courses at NILD-Kolkata, SVNIRTAR-Cuttack, NIEPMD-Chennai and PDUNIPPD-New Delhi.

Candidates are directed to follow the instructions provided in the CET 2023 Information Brochure for e-counselling and to use their respective student dashboard login credentials / Mobile OTPs / registered email id throughout the process of e-counselling.

Important Dates:

1. Payment of e-counselling Fee (**Rs. 500**) and online confirmation of preference of Courses & Institutes (12 options in order of preference) by students – **25-07-2023 to 01-08-2023 till 5.00 PM.**
2. Allotment of seats as per Common Rank to subcategories [CET-2023 information Brochure, Section-5, sub-Section (II)] and as per order of candidate's preference by CET 2023 Admin on **02-08-2023.**
3. Allotment of seats as per Common Rank to all categories [General, SC, ST and OBC], as per order of candidate's preference and choice of category by CET-2023 Admin on **03-08-2023.**
4. Payment of seat locking fee (Rs 10,000) by Students- **05-08-2023 to 09-08-2023 (till 5.00 PM).**
5. Document Verification at respective colleges as per the allotment and online Balance Admission fee Payment [CET 2023 information Brochure Section-10.3, section-6] – **21-08-2023 to 22-08-2023.**

Important Information:

1. CET-2023 Admin will allot the seat/Institute in the order of common merit rank as per available/vacant seat at his/her turn and as per the order of choice confirmed by the candidate, payment of e-counselling Fee (**Rs. 500**). Online filling of preference of Course & Institutes (12 options in order of preference) by students does not guarantee admission.

2. Candidates are advised to lock/book the seat under reserved category if they fail to get their preferred choice of course/institute under general/unreserved category.
3. Call letters/admission offer letter will be sent individually to candidates on their registered email IDs as given by them in their application forms after payment of seat locking fee.
4. Admission at any stage may be withheld/cancelled If any false information or discrepancy is observed at any stage of admission or the period of study
5. No request/demand in any form shall be entertained if any candidate fails to attend/appear/fill up/login to the e-counselling process after the due dates as mentioned above.
